

WARRANTY RIDER INTEGRAL BLINDS OR SHADES PRODUCTS

This Warranty Rider applies to and modifies the individual written product warranties ("Warranty") for all MI branded products manufactured by MI Windows and Doors, LLC ("MIWD") that incorporate integral blinds or shades within the insulated glass unit. Review these terms carefully as they modify the Warranty applicable to the product and the remedies available under that Warranty.

Incorporation

This Rider fully incorporates the terms of the Warranty offered on MI branded products except as set forth herein. In the event of an ambiguity or conflict between this Rider and the Warranty, this Rider shall control.

Applicable Modification

Coverage for the insulated glass unit under the Warranty is modified as follows:

Warranty coverage for obstruction of vision within the insulated glass unit shall be for a period of ten (10) years, measured from the date of original installation. For all other conditions and components of the insulated glass unit, including the blinds or shades, this warranty covers conditions substantially impairing use of those components for a period of one (1) year from the date of original installation. Glass breakage is excluded from the Warranty.

Exclusivity and Disclaimers

THIS RIDER COMBINED WITH THE WARRANTY IS THE EXCLUSIVE WARRANTY OFFERED FOR PRODUCTS OFFERED BY MIWD INCORPORATING INSULATED GLASS UNITS WITH INTEGRAL BLINDS OR SHADES, AND CONSTITUTE THE OWNER'S EXCLUSIVE REMEDY IRRESPECTIVE OF LEGAL THEORY; ALL SUCH OTHER CLAIMS BEING WAIVED. MIWD SHALL NOT BE LIABLE TO OWNER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES AND MIWD HEREBY DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY WITH RESPECT TO MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, OR OTHERWISE ARISING FROM COURSE OF DEALING OR USAGE OF TRADE OR ADVERTISING.

Some states do not allow the exclusion or limitation of implied warranties or incidental and consequential damages, so the above limitations or exclusions may not apply to you. Where disclaimer of implied warranties is prohibited by federal law, any implied warranty is limited to the duration of this express warranty. This warranty Rider gives you specific legal rights and you may also have other rights, which vary from state to state.

Limitations

The Rider provides for replacement of product components only. The Rider does not include shipping (which shall be "F.O.B. MIWD dock"), the provision of labor, repainting, refinishing or the cost thereof. Loss of functionality of hardware in corrosive environments (which includes any dwelling located within two miles of salt water and any dwelling located in Hawaii or the Caribbean Islands) is excluded from coverage. If repair or replacement is not practicable or reasonably available, MIWD may elect to refund the purchase price of the affected product in full satisfaction of its warranty obligations. In no event shall MIWD be liable for an amount in excess of the purchase price of the affected unit.

MIWD SHALL HAVE NO OBLIGATION WITHOUT PROPER NOTICE AND OPPORTUNITY TO PERFORM. This Rider is provided in addition to the standard written Warranty. For more information or a copy of the Warranty, visit: www.miwd.com.

Claim Procedure

In order to properly identify your unique glass unit, the claim must also contain the **factory window order number** from the window warranty label.
