

## ENDOCOTE FINISH LIMITED WARRANTY

**SINGLE FAMILY RESIDENCE APPLICATIONS:** The Endocote Finishing System is the industry's state-of-art door finishing system backed by a superior 10-year limited warranty. Paint and stain finishes on the door slab are warranted against peeling, checking, flaking, or blistering for a period of ten (10) years from the date the door was purchased from BenBilt, not date of installation, or date purchased by the residential warranty holder. Paint and stain finishes on the interior/exterior of the finished frame are warranted against peeling, checking, flaking, or blistering for a period of ninety (90) days from the date the door was purchased from BenBilt, not date of installation, or date purchased by the residential warranty holder.

This warranty is only for the Endocote Finishing System and not the door upon which the finishing system is installed. Moreover, this warranty is only given to the original consumer purchaser and only applies when the finishing system is used upon a single family residence.

**NON-RESIDENTIAL APPLICATIONS:** Where the structure in which the product is installed is not a single family residence or a home occupied by the original consumer purchaser and is owned by a public or private corporation for profit or non-profit, an unincorporated association, or other business entity of any type recognized by law, a church, a school, or a governmental or public authority, the paint and stain finishes on the door slab are warranted against peeling, checking, flaking, or blistering for a period of one (1) year from the date of purchase. Paint and stain finishes on the interior/exterior finished frame are warranted to a Residential Warranty Holder against peeling, checking, flaking, or blistering for a period of ninety (90) days from the date of purchase.

This warranty is only for the Endocote Finishing System and not the door upon which the finishing system is installed.

**COASTAL APPLICATIONS:** When the Endocote Finishing System is installed within (5) miles of salt water ("coastal"), the paint and stain finishes on the door slab are warranted against peeling, checking, flaking, or blistering for a period of five (5) years from the date of purchase.

**EXTREME EXPOSURE APPLICATIONS:** When the Endocote Finishing System is installed in an Extreme Exposure region, the paint and stain finishes on the door slab are warranted against peeling, checking, flaking, or blistering for a period of four (4) years from the date of purchase. The following states are considered to be Extreme Exposure Regions: AK, FL, HI, ID, MT, ND, NM, NV, OR, SD, UT, WA, and WY.

No warranty herein covers damages resulting from improper installation, abuse, negligence, abnormal or unreasonable use (including failure to provide reasonable and necessary maintenance), damages resulting from fire or lightning, windstorms, earthquakes, wind-borne objects, strain applied to the unit by movement of the building, inadequate provision for expansion or contraction of framing members, installation in ships or vehicles, installation outside the continental United States, seal failure (if the seal has been subject to immersion in water), acts of God, or other causes beyond the control of BenBilt Building Systems, LP. Finishes, whether paint or stain, can be affected by varying degrees of exposure to the weather and elements and should not be viewed as "maintenance free."

The sole procedure for obtaining performance of the obligations of this warranty is as follows: if the consumer purchaser believes the Endocote Finishing System as installed is defective, the consumer purchaser must contact BenBilt Building Systems, LP. If BenBilt Building Systems, LP determines that the Endocote Finishing System as installed does not conform to the limited warranties herein, the consumer purchaser's sole remedy will be that BenBilt Building Systems, LP will provide the purchaser with a replacement Endocote Finishing System of equal or lesser value. BenBilt Building Systems, LP reserves the right to discontinue or make changes in any of its products. If the product covered by this warranty is no longer available, BenBilt Building Systems, LP shall have the right to substitute a product that is of equal or lesser value. BenBilt Building Systems, LP will ship the replacement product to the purchaser and the purchaser must pay for any and all labor necessary to install the replacement product, including removal of the original product.

**BENBILT BUILDING SYSTEMS, LP SHALL NOT BE LIABLE TO PURCHASERS FOR CONSEQUENTIAL DAMAGES, SUCH AS, BUT NOT LIMITED TO, DAMAGES OR LOSS TO OTHER PROPERTY OR EQUIPMENT, LOSS OF USE, OR CLAIMS OF SERVICE INTERRUPTION, FOR BREACH OF ANY WRITTEN OR IMPLIED WARRANTIES ON ITS PRODUCT. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO THE PURCHASER.**

Colors are matched as closely as possible to our standards. The color chips used in color selection should be used as a guide only. Slight variation in color is considered normal.

PURCHASERS, DEALERS, CONTRACTORS, APPLICATORS, OR DISTRIBUTORS OF BENBILT BUILDING SYSTEMS, LP PRODUCTS HAVE NO AUTHORITY TO GIVE WARRANTIES ON BENBILT BUILDING SYSTEMS, LP'S BEHALF, THAT ARE DIFFERENT FROM OR EXCEED THOSE LISTED HEREIN. A CONSUMER PURCHASER SHOULD THEREFORE EXAMINE THIS LIMITED WARRANTY CAREFULLY.**

**ALL WARRANTIES, WHETHER EXPRESSED OR IMPLIED, WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED TO THE TERMS HEREIN.** Some states do not allow limitations on how long an implied warranty lasts; so the above limitations may not apply to purchaser.

Any claim asserted under any provision of this warranty must be accompanied by a copy of the proof of purchase and the original packaging of the Endocote Finishing System. The consumer purchaser should maintain these items in a safe and secure place.
